

2020 WARRIOR CASH OFFICIAL GUIDELINES, RULES & CONDITIONS

- 2020 Warrior Cash Program dates are January 1, 2020, through December 31, 2020.
- Contingency payouts will only be made on events listed on www.warriorboatsinc.com. Qualifying events may be added or removed by Warrior Boats, Inc. at any time.
- Warrior boat owners are responsible for sending in a completed angler registration form to Warrior Boats, Inc. no later than fourteen (14) days before an event.
- Must fish all tournament days from your Warrior boat.
- Winner/owner must match Warrior Cash registration and state registration.
- Warrior Cash decals must be displayed on boat during tournament days.
- Warrior Cash decals must be displayed on tow vehicle.
- Must display Warrior logo on hat or shirt during tournament days when permitted.
- Warrior boat owners are responsible for submitting the completed Tournament Affidavit form with tournament results showing all anglers/teams and a W-9 form within thirty (30) days of event. Forms may be found on www.warriorboatsinc.com or email info@warriorboatsllc.com.
- Only the owner of the boat used for the event is eligible for payouts.
- In the case of a combined event, only one payout will be made for both events.
- A maximum of three (3) Warrior Cash payouts will be made to any one angler for the 2020 Warrior Cash Program.
- All taxes are the responsibility of the recipient.
- Warrior Cash payment eligibility will be only authorized by Warrior Boats, Inc.
- Warrior Boats, Inc. reserves the right to change, modify, alter or terminate the Warrior Cash Program at any time.

REQUIREMENTS & TERMS

- I am the registered owner of a Warrior boat.
- I fully understand the Guidelines, Rules & Conditions of the 2020 Warrior Cash Program.
- I understand Warrior Boats, Inc. will make the final decision on all matters including, but not limited to, claims and eligibility for Warrior Cash.
- I will wear required Warrior gear during tournament days as listed in the Warrior Cash guidelines.
- I will place Warrior Cash decals on both tow vehicle and boat.
- I understand that claims will take 4-6 weeks for approval and payment.
- I understand that a maximum of three (3) Warrior Cash payouts will be made to any one angler for 2020 Warrior Cash Program.
- I understand that Warrior Boats, Inc. will file a Miscellaneous Income Form 1099, in conformity with IRS regulations, for each payment and will need a Form W-9 on file to make any payments. Warrior Boats, Inc. will mail a Form 1099 copy to each paid participant for the appropriate tax year.
- I grant permission to use my photograph (or a photograph of my property) with or without name for reproduction in any medium that Warrior Boats sees fit for the purpose of advertising, display, exhibition or editorial use.
- I will complete, sign and return this form to Warrior Boats, Inc. along with the boat registration (state registration or bill of sale) and proper payment fourteen (14) days before the event.

PAYOUTS

Top Registered Warrior Finisher in Any Registered Tournament – \$100

Local Level Win* 75 or more boats – \$500 Less than 75 boats – \$250

Regional Tournaments* (State Circuits or Series & Selected Local Tournaments)

75 or more boats – 1st \$1,000, 2nd \$500, 3rd \$250

Less than 75 boats – 1st \$500, 2nd \$250, 3rd \$125

AIM Weekend Series* – 1st \$1,000, 2nd \$500, 3rd \$250

National Tournaments* (NWT, AIM Pro Series, MWC) – 1st \$2,500, 2nd \$1,500, 3rd \$750

*Payout includes \$100 top Warrior finish.

*2nd owners of a 2016 or newer Warrior boat will receive 50% of any payout.

*Owners of a 2016 or older Warrior boat will receive 50% of any payout.
