Participation Fee

All registered owners of a Warrior Boat – \$100 (Fee includes Warrior Hat & Warrior Cash Decals)

Payouts

Tier 1

- AIM (For events with less than 60 Boats payout will be ½)
- National Walleye Tour

- All Qualifying Events will be Listed on Warrior Cash page under Tier 1

Original Owners with 4 Model Year or Newer Boat

- 1st \$7,500 (Payout will not exceed 1st place payout of tournament)
- \$500 Highest placing Warrior in Top 10
- 60 Boat Minimum Field (Championships & AIM Events are exempt from 60 Boat Minimum)

Non Original Owners & Owners of Boats more than 4 Model Years Old

- 1st \$1,000 (Payout will not exceed 1st place payout of tournament)
- \$250 Highest placing Warrior in Top 10
- 60 Boat Minimum Field (Championships & AIM Events are exempt from 60 Boat Minimum)

Tier 2

- State Circuits
- Series
- Select Local Tournaments
- All Qualifying Events will be Listed on Warrior Cash page under Tier 2

Original Owners with 4 Model Year or Newer Boat

- 1st \$5,000 (Payout will not exceed 1st place payout of tournament)
- \$500 Highest placing Warrior in Top 10
- 60 Boat Minimum Field (Excluding Championship Fields & AIM)

Non Original Owners & Owners of Boats more than 4 Model Years Old

- 1st \$1,000 (Payout will not exceed 1st place payout of tournament)
- \$250 Highest placing Warrior in Top 10
- 60 Boat Minimum Field (Championships & AIM Events are exempt from 60 Boat Minimum)



Tier 3

- Local Tournaments
- All Tier 1 & 2 events under 60 Boats
- All Qualifying Events will be Listed on Warrior Cash page under Tier 3 (<https://warriorboatsinc.com/warrior-cash/>)

Original Owners with 4 Model Year or Newer Boat

- 1st \$2,500 60 Boats or Greater (Payout will not exceed 1st place payout of tournament)
- 1st \$500 30-59 Boats (Payout will not exceed 1st place payout of tournament)

Non Original Owners & Owners of Boats more than 4 Model Years Old

- 1st \$500 60 Boats or Greater (Payout will not exceed 1st place payout of tournament)
- 1st \$250 30-59 Boats (Payout will not exceed 1st place payout of tournament)

How to Qualify & Register

To qualify is easy – be the registered owner of a Warrior Boat.

2024 Warrior Cash Official Guidelines, Rules & Conditions

- 2024 Warrior Cash Program dates are January 1, 2024, through December 31, 2024.
- Warrior boat owners are responsible for sending in a completed angler registration form to Warrior Boats, Inc. no later than fourteen (14) days before an event. **No exceptions will be made.**
- Contingency payouts will only be made on events listed on www.warriorboatsinc.com/warrior-cash/. Qualifying events may be added or removed by Warrior Boats, Inc. at any time.
- Must fish all tournament days from your Warrior boat.
- Winner/owner must match Warrior Cash registration and state registration.
- Warrior Cash decals must be displayed on boat during tournament days.
- Warrior Cash decals must be displayed on tow vehicle.
- WARRIOR must be displayed on all boats as the same size or larger than factory installed and in clear view
- Must display Warrior logo on apparel during tournament hours and weigh-ins. (Photo must be sent in with claim from weigh-ins wearing Warrior Apparel)



2024 Warrior Cash Official Guidelines, Rules & Conditions

- Warrior boat owners are responsible for submitting the completed Tournament Affidavit form, complete tournament results showing all anglers/teams, Photo from weigh –ins, and a W-9 form within thirty (30) days of event. Forms may be found on www.warriorboatsinc.com/warrior-cash/ or email info@warriorboatsllc.com.
- Only the owner of the boat used for the event is eligible for payouts.
- In the case of a combined event, only one payout will be made for both events.
- By participating, in Warrior Cash all participants and the winners agree to release and hold harmless Warrior Boats from any liability whatsoever and waive any and all causes of action arising out of or in connection with the contingencies or the tournaments.
- Each California participant agrees that all rights under Section 1542 of the California Civil Code are hereby expressly waived.
- **A maximum of three (3) Warrior Cash payouts will be made to any one angler for the 2024 Warrior Cash Program.**
- **Warrior Cash Payments will be made on July 1st and November 1st (or Monday closest to these dates if they fall on weekend)**
- All taxes are the responsibility of the recipient.
- Warrior Cash payment eligibility will be only authorized by Warrior Boats, Inc.
- Warrior Boats, Inc. reserves the right to change, modify, alter or terminate the Warrior Cash Program at any time.
